General Information

Introduction

ImportNet was development over ten years ago to provide Importers, Shipping Lines, Freight Forwards and Customs Brokers a simple web based application to communicate with Customs (Australian Border Force) using either our digital certificate or your own. ImportNet offers a means to lodge and manage your Sea and Air Cargo Reports, Cargo Lists and Underbond Movements with ABF, offering;

- PKI compliant, with the exception of Shipping Lines, you are able to use our digital certificate for all cargo reporting;
- Multiple users can access Importnet at the same time enhancing work flow;
- Provides a common web based layout to complete the Sea and Air Cargo Reports, Underbond Movements and Cargo Lists




If you can't access ImportNet from your PC trying using your phone as that will confirm if the issue is a problem with your office internet

To use the ImportNet service, you must be registered and have an active "TG" account number, username and password.

- The homepage shows the noticeboard where new information will be shared, such as new product features and industry news.

The core menu items are within the green bar across the top of the page.

Cimple instructions on fiving your DDA problems

- **Home** this is the first page that appears when you log into ImportNet and shows the noticeboard.
- Manifests used to access or create your air and sea cargo reports
- Underbonds used to access or create your underbond movements
- Cargo Lists used to access or create your cargo lists
- Client Profiles used to access or create your client profiles such as consignee, consignor and notify parties
- **Schedule** used to see vessel schedules
- Registration used to update your company details as well as change your password and add new users
- **Help** will take you to a support pages.
- Logoff logs you off ImportNet.

ImportNet Icons

Commerce Plus uses the same icons across all our applications and their meanings are;

Cargo List Introduction

A Cargo List is a report by a Shipping Line about certain types of cargo being discharged from a vessel on an international voyage. The types of cargo reported:

- shipping line owned empty containers,
- · cabotage and
- export cargo being repositioned prior to export.

The Cargo List is required by ABF to obtain a "release of cargo" where that cargo will not have an associated import declaration. The initial report must be lodged with ABF not less than 48 hours prior to the arrival of a vessel at its first Australian port. Additional lines must be added to a Cargo List, as required, not less than 24 hours before the estimated time of arrival at each subsequent Australian port of discharge. If the journey from the previous Australian port is less than 24 hours, the Cargo List must be submitted before the estimated time of arrival of the vessel at the next Australian port of discharge.

The key fields required by ABF include;

- Vessel identifier (Lloyd's or Customs Ship Register number);
- · Voyage number
- · Original port of loading
- · Port of discharge
- · Port of destination
- Cargo code (cabotage / empty or export)
 - cargo identifier (Container Number, Bill of Lading or Booking Reference Number)
 - break bulk indicator
 - number of packages.

Creating Cargo Lists

To create are Cargo List a header is completed followed by the items with the report.

Header Details

- Click on Cargo Lists on the green menu bar
- Click New
- The **Reference** is a unique id for the Cargo List, it is best practice to use a meaningful name like Vessel Voyage Port, eg 931235 17N AUBNE
- Enter the IMO or click on the magnifying glass to search by name
- Enter the Voyage No, remembering these details should match the impending arrival in ICS
- The **Discharge Port** code, for example AUSYD or click on the magnifying glass to search by name
- The Responsible Party will default to your ABN.





Fields with a * are mandatory

• Click Save

Cargo List Items

- Click New Cargo List Item
- · Set action to Insert
- Select **Cargo Code**;
 - Cabotage break bulk or containerised coastal cargo
 - Empty empty containers
 - Export cargo to be transshipped within Australia before being exported
- Select Cargo Type;
 - FCL Containerised Cargo
 - Bulk

Break Bulk

• Enter the Cargo Id, typically this is a list of containers



Copy and paste a list of containers to save time!

- Enter the **Original Port of Loading** the UNLocode of the first seaport where the consignment was loaded on to a vessel.
- Enter the **Destination** the UNLocode of the final destination port of the cargo.
- Enter the No of Packs if non containerised
- Select a Package Type if non containerised
- Click Save Item




Check the discharge indicator in the ABF / ICS Impending Arrival Report, this is a common cause of issues.

Additional Cargo List Items

For each different combination of cargo type a new item needs to be created using the above process. In the example below you can see there are four containers,

- · Two export containers coming Hong Kong and heading to London and
- Two empty containers from Singapore and going to Sydney






Cargo deemed as Export must has a overseas destination port

Sending Cargo Lists

Once all the line items have been added it is now time to send the Cargo List to ABF.

- Click on Save
- Click on Send
- Confirm the message is an Original as it has not been sent to ABF beforehand
- Click on Send Message




• The status of the Cargo List will now change to "Send".




A CLEAR status from ABF may take 24 hours, the initial status will be ACCEPTED

Checking Cargo List Status

- Click on Cargo Lists on the green menu bar
- Filter for the specific Cargo List or view all as the latest will be at the top of the table, click
 Lookup
- Click on the reference for the specific Cargo List



- The status for each item can be;
 - Insert Not yet provided to ABF
 - Clear Approved by ABF
 - Error Rejected by ABF
 - Withdrawn Withdraw from ABF



Amending Cargo Lists

Altering Cargo List Header

The header details in a Cargo List can't be altered in any way, if they need to be changed the complete Cargo List must be withdrawn.

- Click on Cargo Lists on the green menu bar
- Filter for the specific Cargo List or view all as the latest will be at the top of the table, click **Lookup**
- Click on the reference for the specific Cargo List
- Click on **Send**
- Select Withdraw from the dropdown
- Click on **Send Message**, once it has been withdraw the complete message will change staus to withdrawn

Altering Cargo List Items

- Click on Cargo Lists on the green menu bar
- Filter for the specific Cargo List or view all as the latest will be at the top of the table, click **Lookup**
- Click on the reference for the specific Cargo List
- Click ih pencil icon next to the item needing to be changed
- Change the action to **Delete** if you need to delete the line or edit the changes to the fields.
- Click Save Item
- Click Back
- Click Send
- Select action as Change
- Click **Send Message**
